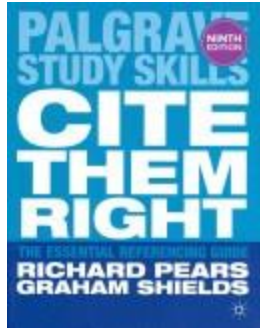

# Referencing and citing

- **What is referencing?** ما هو توثيق المراجع؟ ولماذا؟
- At University you are expected to research widely and build your knowledge on the expertise of others.
- Referencing acknowledges the sources used to develop your ideas, and may include words, images, video, audio, statistics, or websites.
- Quality information strengthens your arguments and adds credibility.
- Referencing enables you, and your readers, to locate your sources and helps to avoid plagiarism.

# Writing References

- **Why should you reference?**
- When you write a paper or a report you must clearly show which are your own ideas and thoughts and what you have taken from others. If you use other people's material you must clearly state the source, otherwise you might be accused of plagiarizing.

- By citing other people's material you give support and render credibility to your own arguments and ideas.
- Always assume there is an interest for your readers to read more about your subject matter. Correctly written references gives your readers easy access to your sources.



# Reference System

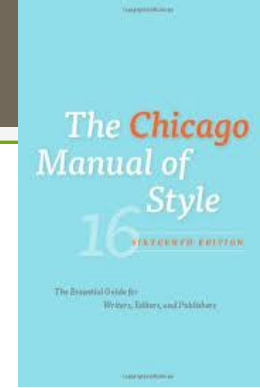
## ما هي الطريقة الافضل لي؟ Which reference system should you use?

There are many ways to reference and write reference lists depending on the reference system being used. Find out which reference system your department or program uses.

### Common Reference Systems

- **Harvard هارفرد**
- Harvard is also known as the author-year-style or parenthetical referencing. For more information see Writing references -Harvard. APA is very similar to Harvard. The most visible difference is that for APA the year is put in brackets in the reference list.
- **Oxford اكسفورد**
- Oxford is also known as the footnote system. For more information see Writing references - Oxford.

# Reference System



- **APA**
- APA is a version of author-year-system that is similar to Harvard. The most visible difference is that for APA the year is put in brackets in the reference list. In APA you do not write page number(s) in the in-text reference (unless you're quoting).
- **Vancouver**
- Vancouver is commonly used within the medical and biomedical field. The in-text references consist of numbers in chronological order. Information about the references is then provided in the reference list according to the chronological order they appear in the text.
- **IEEE**
- IEEE is very similar Vancouver. IEEE is often used by engineering
- **MLA**
- MLA is similar to Harvard. Author and page number(s) should be written in the in-text reference. The major difference between MLA and Harvard is that for MLA year is not written in the in-text reference.

# Harvard System

- **Books with one Author مؤلف واحد**

- Include :author's last name and first name; year of publication; title; edition (if not 1st); place of publication and publisher.

- **Books that have editors (Anthologies)**

- For edited books include (ed.) or (eds.) between the name of the editor and year of publication - as in the example.

Allen, Jeffner and Young, Iris Marion (eds.). 1989. *The thinking muse: feminism and modern French philosophy*. Bloomington: Indiana University Press.

- **E-books كتب الكترونية**

- The same information should be provided as for printed books, see examples above. For books that have been read or downloaded from a library website or bookshop you should add the information that it is an e-book at the end of the reference.

- **Book Chapters فصل في كتاب**

- Include : Last name(s) and first name(s) of author(s) of book chapter. Year of publication. Title of book chapter. **In** first and family name(s) of editor(s) in brackets. *Title of book*. Edition (if not 1:st). Place of publication: publisher, page numbers of chapter.
- Malmberg, Anders. 2003. *Beyond the cluster: local milieus and global connections*. In Jamie Peck and Henry Wai-chung Yeung (eds.). *Remaking the Global Economy*. London: Sage Publications, 145-162.

- **Journal Articles دوريات**

- Include : Last name(s) and first name(s) of author(s). Year of publication. Title of article. *Journal name* Volume (issue): page numbers of article.

- **Electronic Journal Articles دوريات الكترونية**

- Same information included as for journal articles (see example above) and a DOI-number. DOI (Digital Object Identifier) is used to uniquely identify an object such as an electronic article. DOI-numbers are permanent, which makes it possible to easily locate articles even if the URL of the article has changed. Articles are assigned DOI-numbers by major academic publishers. If there is no DOI-number you should give the URL-link of the article and in some cases access date (mainly articles that are freely available on the internet). The publisher often states how to write the reference.

- **Newspaper Articles** مقال بجريدة

- Include :author of article. Year of publication. Title of article. *Name of paper or magazine.* Day and month of the article

- **Newspaper articles on the web** مقال بجريدة الكترونية

- Same informaton as for a printed article (see above) and URL of article and date of access in brackets. If the URL is very long it could be sufficient to use the URL of the newspaper e.g <http://www.time.com/time/>.

- Include :author, organization, authority or company. Last update of web page (year). *Title of document or page.* Name of web site or owner of web site. Complete URL (<http://.....>) (Access date).

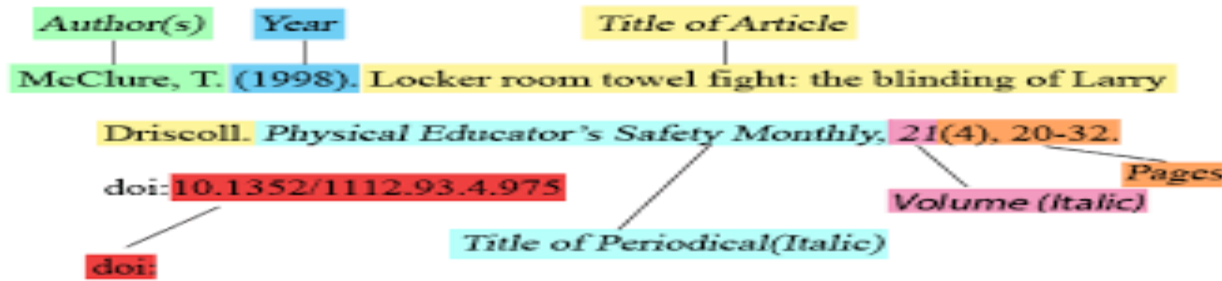

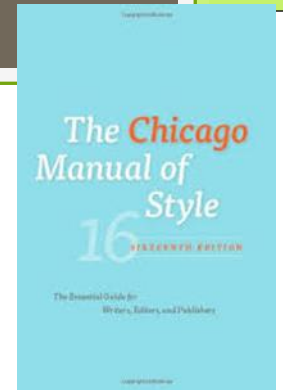
## ○ **Conference Proceedings مؤتمرات**

- Lectures/presentations at conferences and seminars are published in anthologies called proceedings. Title, year and city of conference are to be included if known. Individual contributions to conference proceedings, if published in their totality (not abstract only) are treated as chapters in books.
- Hall, C. Michael. 2007. North-south perspectives on tourism, regional development and peripheral areas. In Dieter K. Müller and Bruno Jansson (eds.), *Tourism in peripheries : perspectives from the north and south*, 19-38. Perspectives on tourism in Nordic and other peripheral areas, 2004, Umeå. Wallingford: CABI.
- Sometimes those contributions that are only represented by abstracts in the proceedings are published in journals. You should in these cases not refer to the abstract in the proceeding but to the full article in the journal where it was published.
- **Illustrations (photographs, figures, diagrams, tables etc.) صور ، جداول ، رسومات**
- Illustrations created by others are often protected by copyright. In those cases you need permission from the copyright owner before you can use the illustrations in your text. If possible always state the creator of the illustration in the reference list.

- State the name of the illustrator if different than the author of the work. If available also provide page number of the illustration:

## ○ **Personal Communication** مقابلة شخصية

- Personal communication includes more informal sources: e.g. letters, e-mails, phone calls or conversations. Permission should be sought before these sources are quoted, and a copy retained for reference. If you have promised an interviewee anonymity you must keep that promise
- Please note that personal communication is sometimes not included in the reference list as the sources normally are not traceable. In those cases information about personal communication are provided only in the footnotes!
- A reference to personal communication should include as much information as possible; name, profession/position, year, details of personal communication; date (day and month)

# Oxford System



This is a guide on how to write references for various documents Oxford style intended for footnotes with complete bibliographic information and reference lists. This guide is mainly based upon recommendations given in the book *The Chicago Manual of style*.

## Books with one Author

- Include (if available): author's last name and first name; title; edition (if not 1st); place of publication and publisher, year of publication.
- Bryman, Alan. *Social research methods*. 3rd ed. Oxford: Oxford university press, 2008.

- Some books whose copyright have expired are sometimes freely available on the internet. In those cases you should add the complete URL ([http ://...](http://...)) and access date, the date you downloaded/read the book. If the URL is very long it could be sufficient to use the URL of the web site where you found the book e.g. <http://books.google.se/>

- **Book Chapters** فصل بكتاب

- Include (if available): family name(s) and first name(s) of author(s) of book chapter; title of book chapter; **In**, title of book; first and family name(s) of editor(s) and ed(s) in brackets; edition (if not 1:st); page numbers of chapter; place of publication and publisher; year of publication

# Citing References

## الاقتباس - Harvard System

- In this version of the Harvard system an in-text reference should include the author, the year of publication and, if applicable, page number(s). Please note that there are other "versions" of the Harvard system where page numbers are not always stated in the in-text reference. The in-text reference is placed directly in brackets after the sentences (before the full stop) you have paraphrased, i.e. the sentences you with your own words have expressed what someone else has written (see example below).
- A reference list of all documents/sources cited in the text is included at the end of the report/paper, in alphabetical order by authorship with date. This reference list will include the full details of the documents. For more information on how to write references for specific documents included in references lists.
- **Source with one author**
- The structure of the European Union is often described in the shape of three pillars. The first pillar is the largest (Tallberg 2004, 65).
- You can also reference your source directly (See example below).
- Tallberg (2004, 65) describes the structure of the European Union in the shape of three pillars, of which the first pillar is the largest.

- **Source with two or three authors**

- (Fossum, Skantz and Katzeff 1997, 25-31) or
- Fossum, Skantz and Katzeff (1997, 25-31) mean...

- **Source with four or more authors**

- Where there are more than three authors, only the first author should be used, followed by 'et al.'
- (Johnson et al. 2001, 226) or
- Johnson et al. (2001, 226) found that...

- **Web pages**

- The same information should be included as for other documents; author, year of publication and, if applicable, page number(s). If there is no personal author, use the corporate author (company, organization, authority etc.).  
(Volvo 2008) or
- According to Volvo (2010)....

- **Material with no personal author**

- Sources may not have a personal author, but organizations, companies, authorities will function as "authors" in those cases. If a journal article does not have a personal author, use the title of the journal as an in-text reference.  
(Frankfurter Allgemeine 2015, 21)

- **No year of publication available**

- If no information about year of publication is available state n.d. (no date).
- (Johnson n.d., 15)

- **Several works by one author in the same year**
- If you are quoting several works published by the same author in the same year, they should be separated by adding a lower case letter directly after the year for each item. Please note that the works should be separated the same way in the reference list (by adding a lower case letter after the year).
- Example:  
Previous results confirmed the thesis (Duncan 2000a, 167-169), but later research disproved it (Duncan 2000b, 40-44).
- **Illustrations (photographs, figures, diagrams, tables etc.)**
- You can cite illustrations in your text without including the actual illustration in your text. If you include an illustration made by someone else in your paper you must check if it is protected by copyright. For illustrations protected by copyright you must ask for permission from the copyright owner before you include them in your text. If you use an illustration in your paper include a caption with the following information image number (e.g. Figure 1), title, creator of illustration and year. Cite the person (artist, photographer etc.) who have made the illustration in the running text.
- Image 5 (Hazel 2015, 32) is a typical example of...
- The painting "The fighting temeraire" (Turner 1839) shows..

# Citing References – Oxford System الاقتباس

- In the Oxford system the citations in the text normally consist of a raised (superscript) number and a list of footnotes at the bottom of the page for all citations on that page.
- If you write complete bibliographic information in the footnote about the document cited (see footnote 1 below) it is sometimes not necessary to include a reference list.
- cited in the text should be included in alphabetical order at the end of the paper/report. If you only include abridged bibliographic information about the documents cited (footnote 2 below) a reference list should normally be provided. For more information about how to write references for specific documents.

## Quoting

- note that "long" quotations are generally not acceptable even if they are treated as "quotations" and should be avoided. If you are uncertain, please contact your teacher/supervisor to receive instructions as to how to use quotations.
- If you want to include text from a published work in your essay/paper, the sentence(s) must be included within quotation marks (""). When you quote from a source always state the page number of the original document from which you quote. This also applies to electronic documents in PDF-format.
- **Examples (Harvard system)**
- The author writes "...plants and localities are also often inter-related with non-local actors" (Eriksson 2009, 29).
- "Place specific phenomena can always be seen in relation to other places and geographical levels" (Helgesson 2006, 13).
- or directly
- Helgesson (2006, 13) states : "Place specific phenomena can always be seen in relation to other places and geographical levels."
- It is good practice to indent the quotation using quotation marks if it is more extensive (i.e. several sentences). This clearly identifies the quotation as the work of someone else.
- **Example (Harvard)**
- Lundmark (2006, 26) states:
- The difficulty in delimiting the tourism sector is one of the more complicated methodological problems.

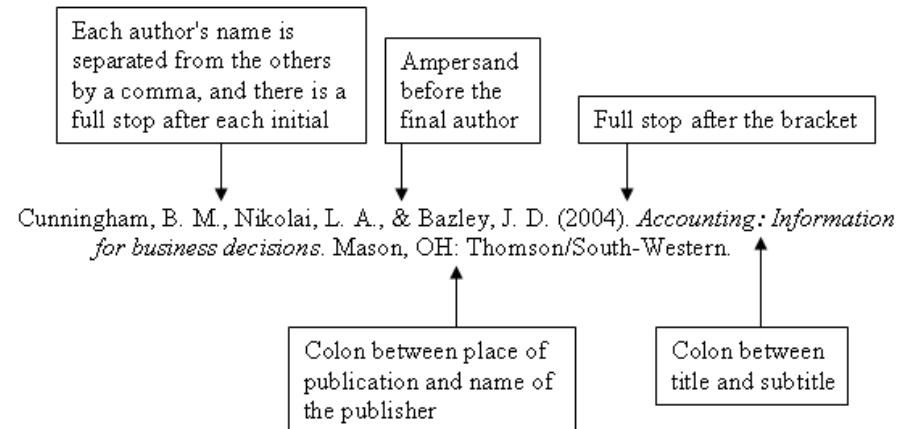
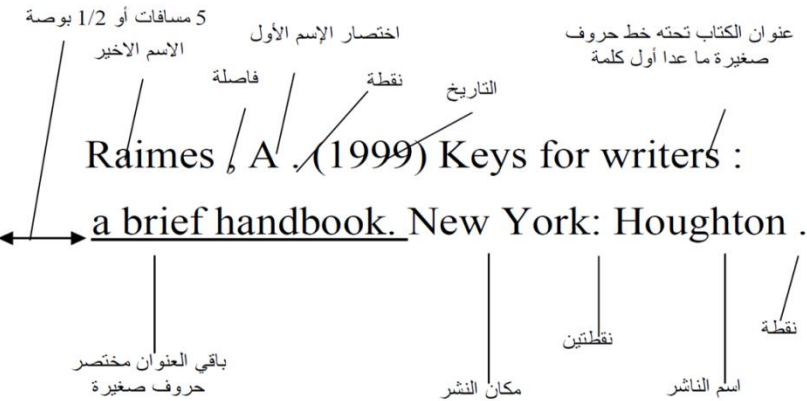
